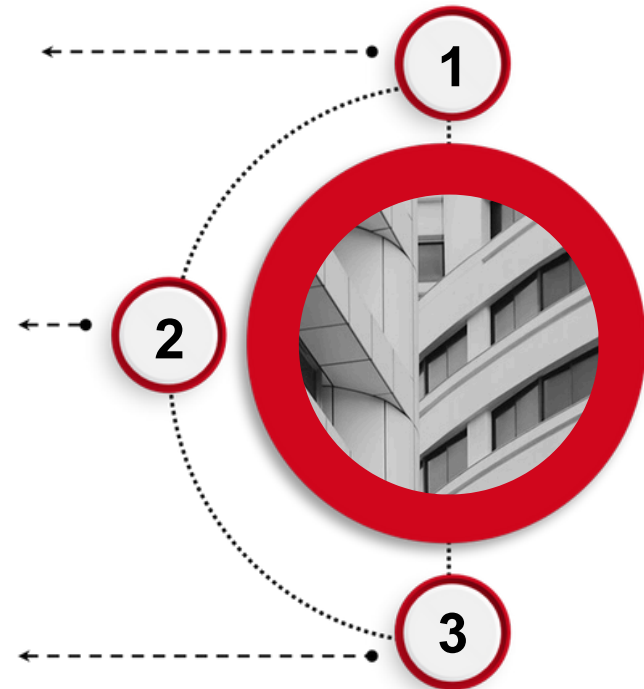

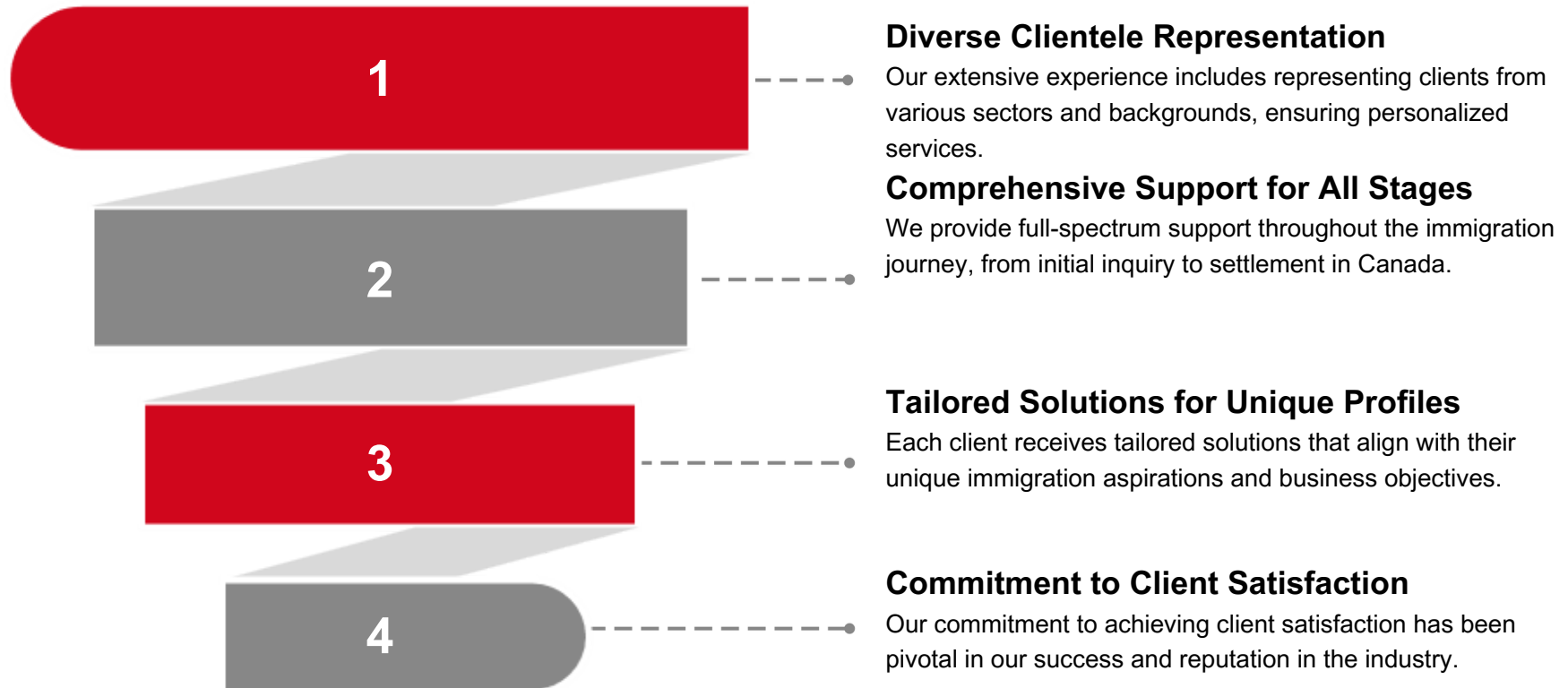

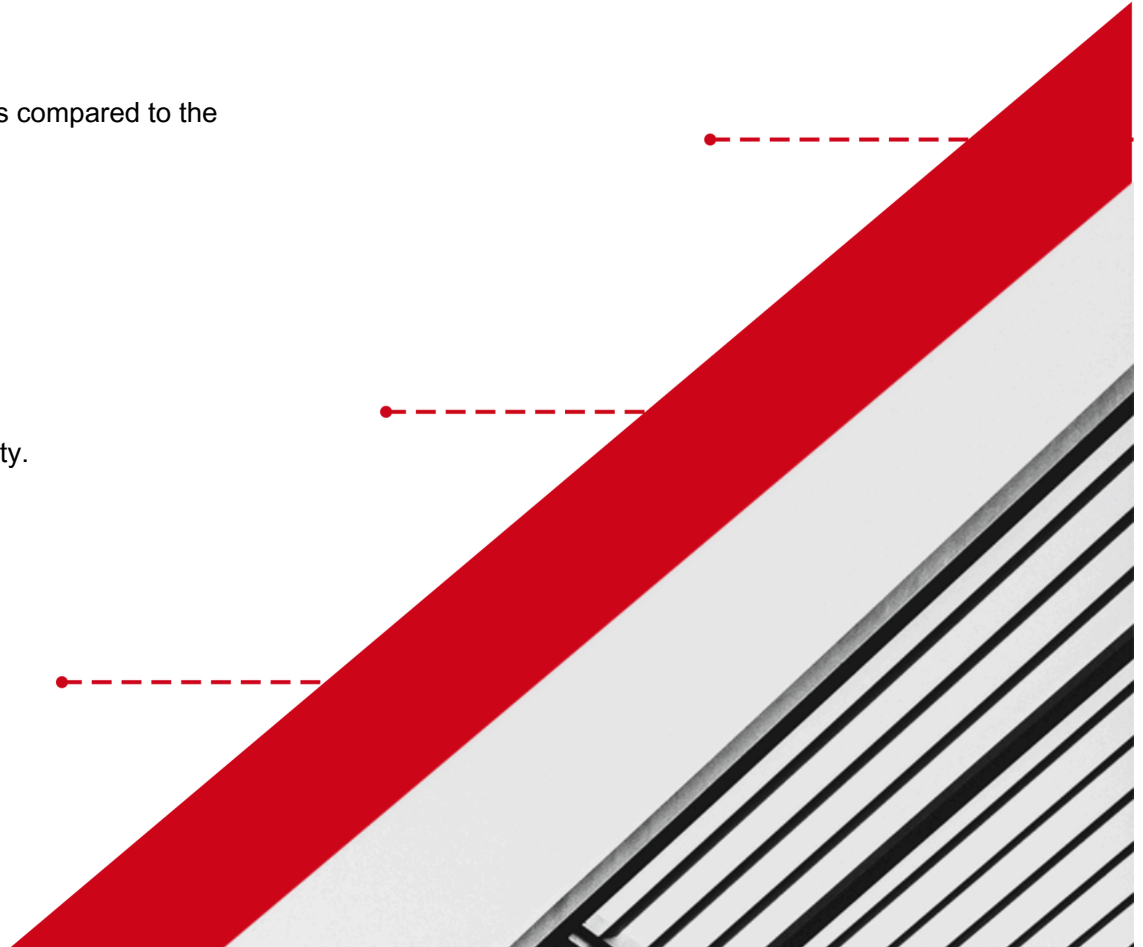

Minimum Ownership Duration

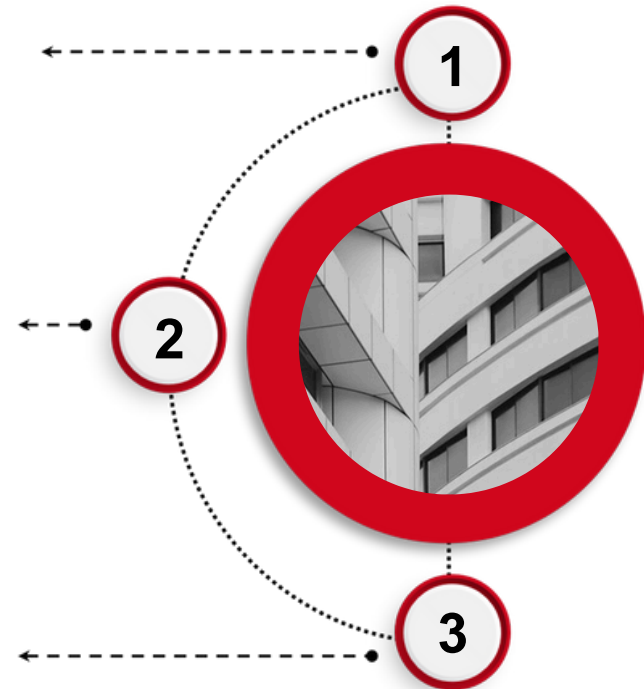
A requirement to demonstrate at least three years of ownership and management experience in a farm business.

Net Worth Verification

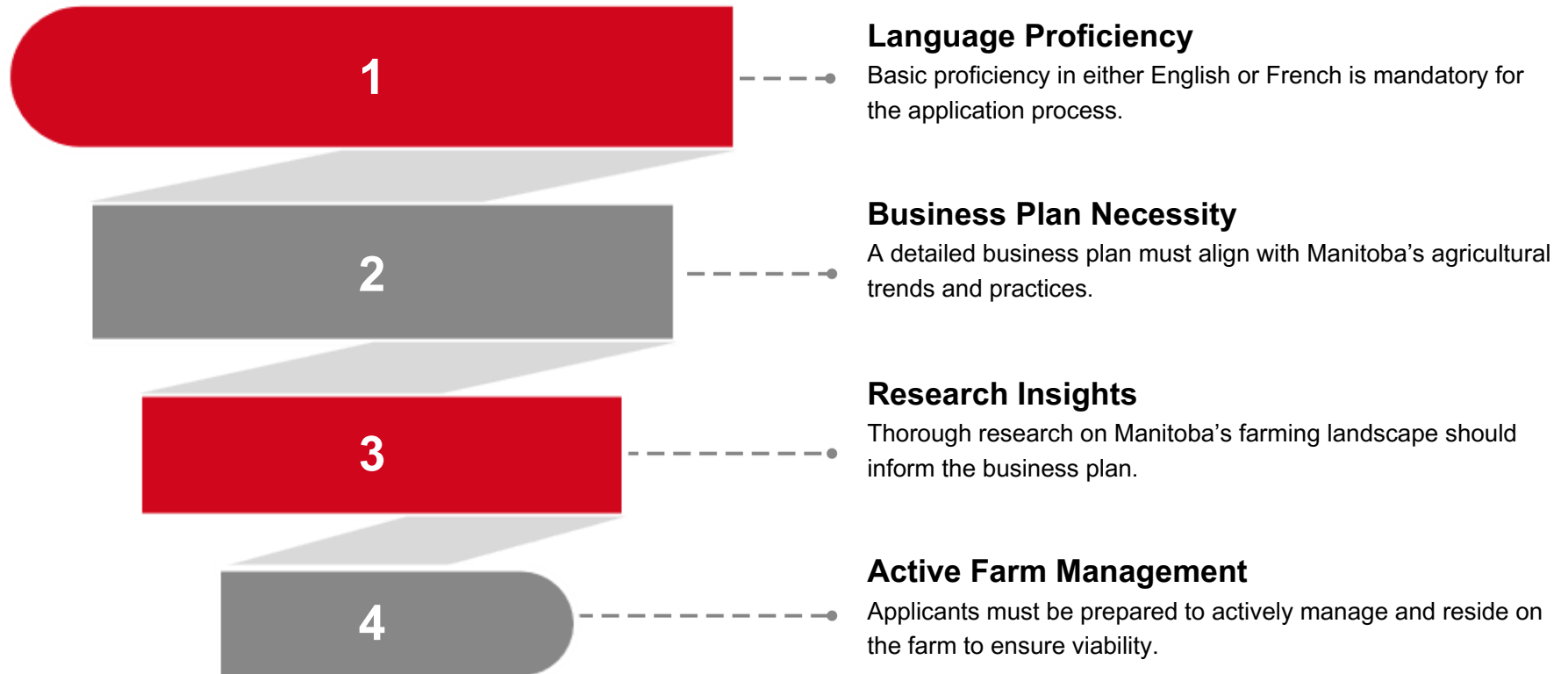
Candidates are required to demonstrate a verifiable net worth of at least CAD 500,000.

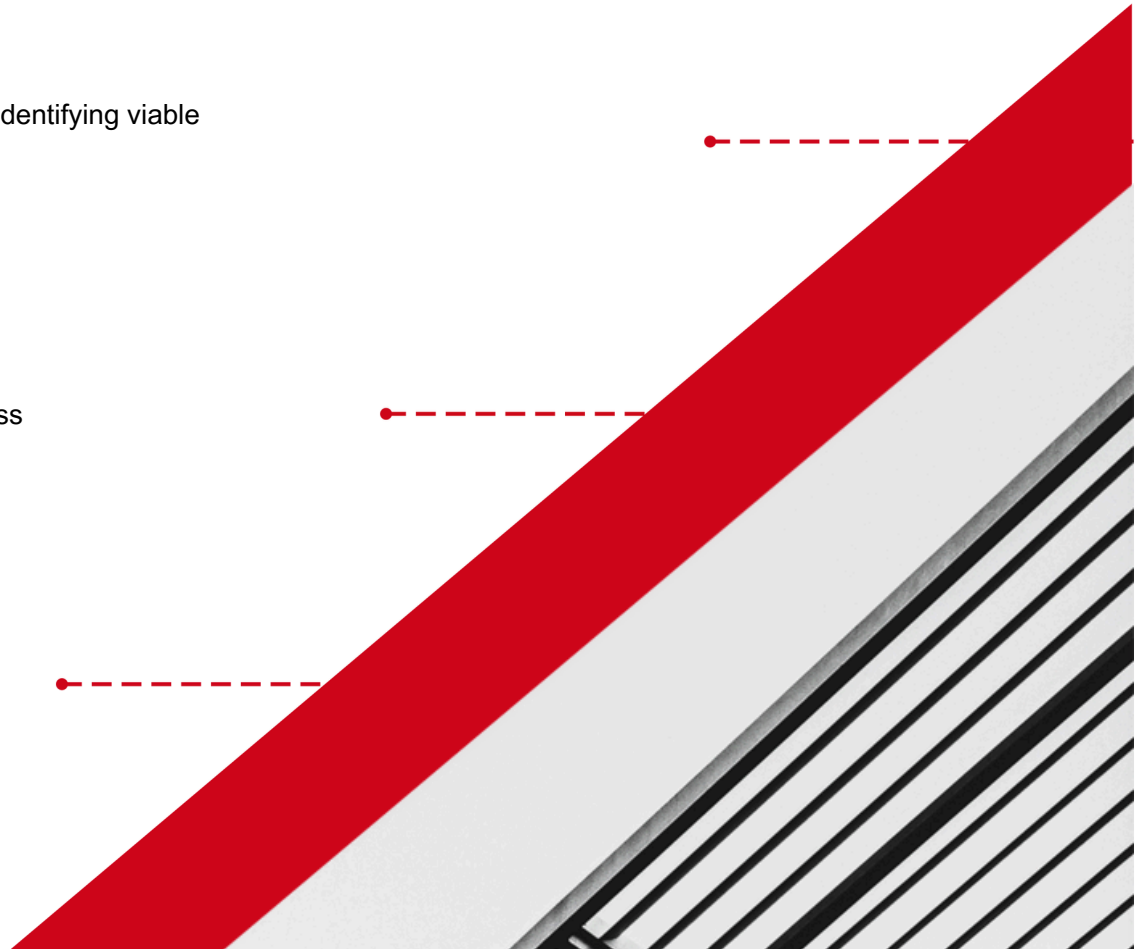

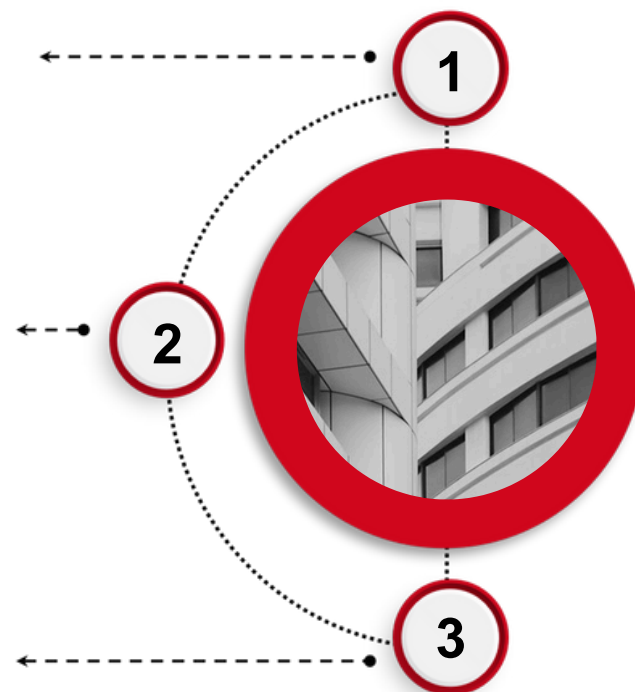
